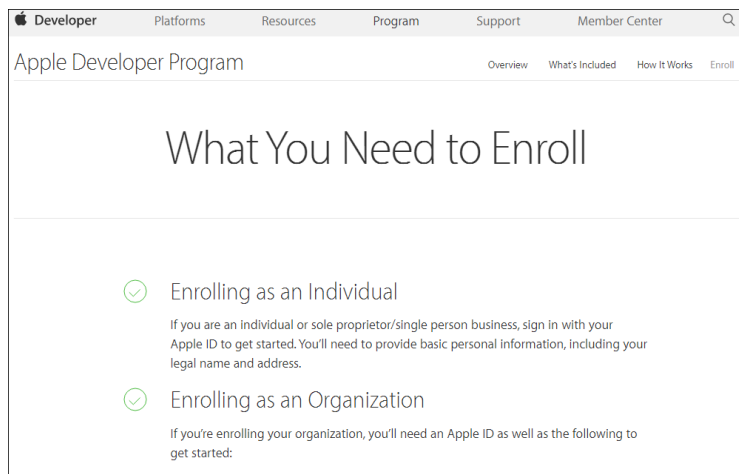

Elo PayPoint for iPad to Apple AppStore

Overview

Thank you for developing an iOS App for use with Elo Paypoint iOS hardware. Depending on the Elo model number, the Paypoint for iPad hardware is compatible with iPad 4, iPad Air, iPad Air 2, iPad Pro 9.7", iPad (5th Generation), and iPad Pro 12.9". Apple iTunes is a great way to get your App into users hands.

1. In order to get your app within iTunes, register your Application with Apple Complete development and testing of your application. Prepare your application using the standard Apple App submission process. <https://developer.apple.com/app-store/submit/>



2. Elo must first submit App Developer Details to Apple MFi, please provide the below information to Elo Touch Solutions by emailing: elosystemsteam@elotouch.com

Please Note: Apple MFi must approve the App before an App is submitted to iTunes Connect.

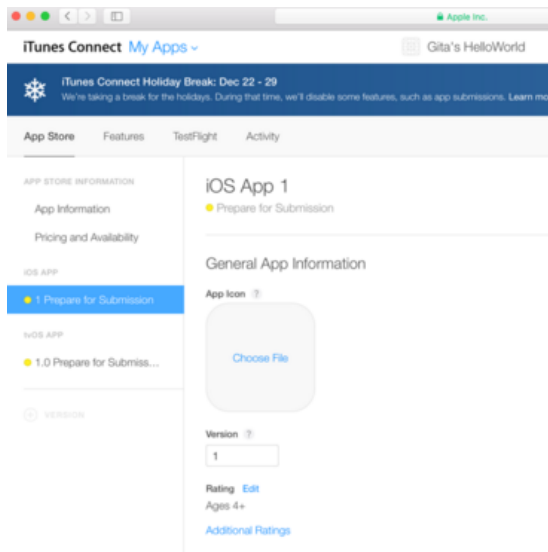
In addition, if submitting for MFI approval for PayPoint Plus, specify all Star printers that will be supported by your application (PayPoint Printer, TSP100IIU, TSP650IIBI, TSP700IIBI...). This information is required when receiving MFI approval from Star Micronics.

3. When submitting within *iTunes Connect*, specify protocol names that match the device.

The *UI Supported External Accessory Protocols* key in the app's Info.plist must contain one or more names that match the device's protocol names.

Elo's protocol name is: com.elotouch.protocol

4. Submit the MFI PPID for the device within *iTunes Connect* to complete your AppStore submission. Once you have this information from Elo, update your portal and submit your App to AppStore.



Place the device's MFI PPID within the apps metadata *Review Notes* field.
